Note: Vegetation / Plantation is completed on the abandoned Ash Ponds no 1 & 2. We have done vegetation / plantation directly on Ash. Till March 2023, vegetation / plantation on 61.01 Lacs MT Ash has been completed. This has been done as per MoEF CC Fly Ash notification Dec-2021 and its amendment as on Dec-2022. Hence, vegetation on entire legacy ash is completed. ADTPS left with only one operational ash pond i.e Ash No. 03. Simultaneous disposal and lifting of pond ash from the same pond is not possible as the entire pond is wet.
