This Forum decided the grievance on 05/10/2021. In Point No.2 of the Order, it is ordered that *"The Complainant/Applicant to pay outstanding amount of Rs.44,208.36 in 4 (Four) monthly installments, 1st installment is of 44,208.36 is due on 15/10/2021"*. It is pertinent to note that the Respondent wants to clarify the second part of the Point No.2 Order.

It is pertinent to note that there appears to be typographical error in second part of the Point No.2 of the said order. Instead of '*1st installment is of 44,208.36*', there ought to have been mentioned '*1st installment out of Rs.44,208.36*'. So, there appears to be a typographical error in respect of word '*is*'.

Provisions of Civil Procedure Code is not applicable to this Consumer Forum. If there is any arithmetical, typographical error is committed then the same can be rectified under Section 152 of Civil Procedure Code.
