2. The Applicant/Complainant, stated in their grievance application submitted to CGRF that they are the consumers of Adani Electricity Mumbai Limited since 06/02/2020. The residential room located at B-1930, Priyadarshani Sahkari Gruhnirman Housing Society, Indira Nagar No.1, Near Datta Mandir, Sainath Nagar Road, Ghatkopar (West), Mumbai 400086, was originally owned by Secretary (Adinath Satsang Sampraday Mandal) having Account No. 101850526.
